 PUBLIC HEARING: Adopt Resolution 16-006 replacing Resolution 15-018 "Fee Schedule" to change the fee amount required for submitting a building permit application – Planning & Building Director Micah Austin.

Micah Austin Director of Planning and Building explained the new resolution and the changes from Resolution 15-018. Micah Austin read the language change. He explained what fees will be paid up front and what fees will have to be within 5 days of issuance of building permit.
