**b.** Resolution No. 15-020 Restricting the Use of Single Use Plastic Water Bottles at City Properties and Facilities

Suzanne Frick City Administrator explained the 2014 Comprehensive Plan and the alternatives to the single use plastic water bottles.

Councilor Anne Corrock would like to see the alternative in place prior to this step. She suggested a Ketchum Water Bottle to sell. Suzanne Frick explained the steps the steps the city will be taking to implement Resolution 15-020. Mayor Nina Jonas would like alternative bags be added to the Ordinance.

Mayor asked for public comment.

Neil Bradshaw works for a water bottle company. He said he supports what the city is doing. He has done extensive research on size and people like 20 to 24 oz. bottles. He suggested the city get a higher end water bottle to not add to the waste problems. He encouraged the city to continue.

Dani Mazzotta resident of City of Ketchum said she is in support of this resolution and would plastic bags added.

Mayor Nina Jonas closed public comment.

Council President Michael David questioned why we are going with a resolution rather than an ordinance. Suzanne Frick explained that the City did not want to be so heavy handed. This is for events on City Property only. We are not banning city wide. The sales and distribution at the event is what is being banned.

Councilor Baird Gourlay would like Styrofoam added to the resolution.

Motion to approve adoption of Resolution 15-020 to prohibit the sale and distribution of single-use water bottles at city properties, facilities and city events and to include plastic bags and Styrofoam.
